You will notify us if the confidentiality of your Password is compromised. You will receive login information in and expedient manner of time.						
Credit Card/Home Equity Loan or Line: You are applying to obtain credit from Belmont Bank & Trust ("we" or "us"). If you do not like the terms of the agreement we send you with your card, you can rescind you agreement with us by returning your card to us. If you use the card, you agree to the terms of the agreement.
